Throughout most of the fiscal year, schools remained in remote learning mode. NatureTrack did provide cost-free outdoor field trips for students attending the Lompoc YMCS program. NatureTrack continued providing virtual field trips and activities for students and teachers. In December 2020, NatureTrack volunteers began delivering meals to students whose families found not picking up their school-provided meals. Each meal was delivered with a NatureTrack produced "Nature Card" that consisted of outdoor activity. The program was coined "Nutrition With a Side of Nature." More than 4,000 meals were delivered from December 2020 to June 2021. By April 2021, some schools returned to in-person learning and reserved outdoor field trips. With strict COVID safety protocols in place, NatureTrack provided 200+ students switch a cost-free, curricula-aligned outdoor experience.

Due to COVID, the third annual NatureTrack Film Festival (NTFF) was moved to October and screened virtually from October 9 through 18. Passes and tickets purchased for the in-person March 2020 were honored. Refunds were offered, but most all patrons opted to enjoy the virtual festival.
